13.SHARED INFORMATION

The following items were shared by Members: -

- Cllr Williams reported that there is a new National Planning Policy Framework in place which could impact on nerghbourhood plans. It was agreed to start a discussion with CWAC about this matter and the potential issues.
- Cllr Strachan raised the issue of fingerposts being painted in the parish. Will make an enquiry with CWAC Highways.
